1 **AN ORDINANCE RENEWING THE BID AWARDS FOR CERTAIN**
2 **PRODUCTS AND SERVICES FOR LUBE OILS, ANTIFREEZE AND GREASE**
3 **2018, DEPARTMENT OF PUBLIC WORKS, DIVISION OF FLEET SERVICES.**

4 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") recommends
5 the renewal of the following bid awards at the same terms and conditions as previously bid,
6 as authorized by the original Invitation for Bid awarded by the County, for an additional
7 one-year term:

14 **WHEREAS**, the Department of Public Works, Division of Fleet Services of
15 Jefferson County, Missouri, requested renewal from the awarded bidder to renew their
16 contract for the Lube Oils, Antifreeze and Grease 2018 with the County; and

17 **WHEREAS**, the Department of Public Works, Division of Fleet Services of
18 Jefferson County, Missouri, finds it is in the best interest of the County to renew the bid
19 award for Lube Oils, Antifreeze and Grease 2018 for the term of 4-1-19 to 3-31-20 with

1 Bauman Oil Distributors, Inc. with approval of the County Council and County Executive
2 up to **\$25,000.00 per term, for total amount not to exceed \$25,000.00 for the term,**
3 subject to budgetary limitations.

6 Section 1. The County authorizes the renewal of the bid awards for an

19 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
20 County Executive to execute a renewal agreement, attached hereto and incorporated herein
21 by reference and attached as Exhibit A. The County Executive is further authorized to take
22 any and all actions necessary to carry out the intent of this Ordinance.

1 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
2 thereto, and any contracts or agreements shall be maintained by the Department of the
3 County Clerk consistent with the rules and procedures for the maintenance and retention
4 of records as promulgated by the Secretary of State.


5 Section 4. This Ordinance shall be in full force and effect from and after its
