4           **WHEREAS**, Pursuant to Ordinance 18-0271 Jefferson County, Missouri and the  
5 Department of Public Works entered into a Contract, known as the Welding Equipment  
6 and Maintenance 2018 Contract, with Airgas and Ozarc Gas; and

7           **WHEREAS**, the Department of Public Works of Jefferson County, Missouri,  
8 requested renewal from the awarded bidders, Airgas and Ozarc Gas to renew the Welding  
9 Equipment and Maintenance 2018 Contract, and Ozarc Gas declined to renew the Contract;

11           **WHEREAS**, the Department of Public Works wants to proceed with the renewal  
12 with Airgas for the Welding Equipment and Maintenance 2018 Contract; and

9           of records as promulgated by the Secretary of State.


10            Section 4.     This Ordinance shall be in full force and effect from and after its




