1           **WHEREAS**, the Department of Public Works, Division of Fleet Services of  
2 Jefferson County, Missouri, requested renewal from the awarded bidders, Ed Roehr Safety  
3 Products and Public Safety Upfitters to renew the contract for the Emergency Vehicle






