1 **AN ORDINANCE RENEWING THE BID AWARDS FOR CERTAIN**
2 **PRODUCTS AND SERVICES FOR CHANNEL POST 2018, DEPARTMENT OF**
3 **PUBLIC WORKS.**

4 **WHEREAS**, Pursuant to Ordinances 18-0142 and 19-0387 Jefferson County,
5 Missouri entered into a Contract, known as the Channel Post 2018 Contract, with Vulcan
6 Signs; and

7 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") recommends
8 the renewal of the following bid awards at the same terms and conditions as previously bid,
9 as authorized by the original Invitation for Bid awarded by the County, for an additional
10 two-year term:

17 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri,
18 requested renewal from the awarded bidder, Vulcan Signs to renew the contract for the
19 Channel Post 2018 with the County; and

1 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri, finds
2 it is in the best interest of the County to renew the bid award for Channel Post 2018 for the
3 term date of approval to 2-10-22 with Vulcan Signs 2018 with approval of the County
4 Council and County Executive up to **\$45,000 annually, for total amount not to exceed**
5 **\$90,000.00 for the term**, subject to budgetary limitations.

6 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**
7 **AS FOLLOWS:**

8 Section 1. The County authorizes the renewal of the bid awards for an
9 additional one-year term as follows:

13 Date of approval to 2-10-2022

14 Upon approval of the County Council and County Executive

15 AMOUNT

16 **Up to \$45,000.00 annually,**

17 **for total amount not to exceed \$90,000.00 for the term,**

18 subject to budgetary limitations

19 AWARDED BIDDER

20 Vulcan Signs 2018

21 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
22 County Executive to execute a renewal agreement, attached hereto and incorporated herein

1 by reference and attached as Exhibit A. The County Executive is further authorized to take
2 any and all actions necessary to carry out the intent of this Ordinance.

3 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
4 thereto, and any contracts or agreements shall be maintained by the Department of the
5 County Clerk consistent with the rules and procedures for the maintenance and retention
6 of records as promulgated by the Secretary of State.


7 Section 4. This Ordinance shall be in full force and effect from and after its


