1 **AN ORDINANCE RENEWING THE BID AWARDS FOR CERTAIN**
2 **PRODUCTS AND SERVICES FOR INTERNATIONAL TRUCK PARTS,**

4 **WHEREAS**, Pursuant to Ordinance 19-0554 Jefferson County, Missouri entered

1 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri,
2 requested renewal from the awarded bidder, Rush Truck Centers of MO Inc., and Summit
3 Truck Group to renew the contract for the International Truck Parts, Supplies & Repair
4 2019 with the County; and

5 **WHEREAS**, the Department of Public Works of Jefferson County, Missouri, finds
6 it is in the best interest of the County to renew the bid award for International Truck Parts,
7 Supplies & Repair 2019 for the term of 3-9-20 to 3-8-21 with , Rush Truck Centers of MO

5 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
6 County Executive to execute a renewal agreement, attached hereto and incorporated herein
7 by reference and attached as Exhibit A1 and A2. The County Executive is further
8 authorized to take any and all actions necessary to carry out the intent of this Ordinance.

9 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
10 thereto, and any contracts or agreements shall be maintained by the Department of the
11 County Clerk consistent with the rules and procedures for the maintenance and retention
12 of records as promulgated by the Secretary of State.

13 Section 4. This Ordinance shall be in full force and effect from and after its
14 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
15 shall not affect the remainder of this Ordinance.


