1           **AN ORDINANCE RENEWING THE BID AWARDS FOR CERTAIN**

4                   **WHEREAS**, Pursuant to Ordinances 19-0236 Jefferson County, Missouri entered

4    requested renewal from the awarded bidders, Custom Products Corporation, Lightle  
5    Enterprises of Ohio LLC, MD Solutions, Vulcan Inc. DBA Vulcan Signs, and Osburn  
6    Associates Inc., to renew the contract for the Roadway Signs 2019 with the County; and

**WHEREAS**, the Department of Public Works of Jefferson County, Missouri, finds the best interest of the County to renew the bid award for Roadway Signs 2019 for a term of 4-6-2020 to 4-5-2021 with Custom Products Corporation, Lightle Enterprises LLC, MD Solutions, Vulcan Inc. 18      of records as promulgated by the Secretary of State.


19           Section 4.     This Ordinance shall be in full force and effect from and after its
