WHEREAS, the above bounded principal has applied and will apply to the JEFFERSON COUNTY HIGHWAY DIVISION for permission to construct facilities on or across certain highways in MISSOURI and agrees to construct all said facilities and all attachments at such places as the County Engineer of the JEFFERSON COUNTY HIGHWAY DIVISION or its Deputy Engineer shall designate and agree not to trim or cut any trees or shrubs within or along any County Highway right-of-way without detailed written permission of the County Engineer, therefore, and will always install said facilities and fixtures to the satisfaction of the County Engineer and in such a way as to not be a hazard to the traveling public or interfere with the maintenance of the highway.

NOW, THEREFORE, the conditions of this obligation is such that if the said principal, its successors, assigns, executors, administrators, employees, agents, or contractors shall at all times as long as any construction work is being performed within a county highway duty observe and perform all and singular of the agreements, and conditions as above set out to be observed and performed by said principal, then this obligation shall be void, otherwise to remain in full force and effect until ninety (90) days after written notice of termination or cancellation shall be given the County Engineer or the JEFFERSON COUNTY HIGHWAY DIVISION by the surety.
